- i. pelumba sukan bermotor diberi pengecualian duti import, duti eksais dan cukai jualan ke atas kenderaan, motorsikal, *go-kart, mini bike, speedway bike*, tayar, alat ganti dan *safety apparel* yang diperlukan bagi sukan bermotor; dan, *motor sports competitor is given import duty, excise duty and sales tax exemption on motor sports vehicle, motorcycle, go-kart, mini bike, speedway bike, tyre, spare parts and safety apparel for use in motor sports: and,*
- ii. *Motorsports Association of Malaysia* dibenarkan bertindak sebagai badan pengawal ke atas pengimportan dan pengeksporan kenderaan, motorsikal, *go-kart, mini bike, speedway bike*, tayar, alat ganti dan *safety apparel* yang diberi pengecualian cukai. *Motorsports Association of Malaysia is authorised to act as the governing body to the importation and exportation of motor vehicle, motorcycle, go-kart, mini bike, speedway bike, tyre, spare parts and safety apparel which exempted from tax*

Syarat Utama  
*Main Condition*

- i. hendaklah diimport dan didaftarkan atas nama pelumba yang ditentukan oleh *Motorsports Association of Malaysia*. *to be imported and registered under the competitor name verified by Motorsports Association of Malaysia*
- ii. hendaklah digunakan untuk tujuan perlumbaan sukan bermotor sahaja dan tidak boleh didaftarkan untuk kegunaan jalan raya, *applicable for motor sports competition only and can not be registered for normal road use.*
- iii. hendaklah disenaraikan dalam " *inventory list* " *Motorsports Association of Malaysia* untuk tujuan pemeriksaan kastam; *to be listed in the Motorsports Association of Malaysia inventory list for the purpose of Customs inspection:*
- iv. tidak boleh dijual/tukar milik kepada pihak lain tanpa mendapat kebenaran bertulis dari *Perbendaharaan*; *can not be sold or transferred to other party without written approval from the Treasury.*
- v. kebenaran pengecualian ini boleh dimansuhkan pada bila-bila masa oleh *Perbendaharaan* tanpa memberi apa-apa sebab. Pelumba dikehendaki membayar balik duti/cukai yang diberi semasa pengecualian seolah-olah tiada pengecualian cukai diberi; dan *this exemption can be withdrawn at any time by the Treasury without giving any reason. Competitor are required to pay the duties/taxes granted on exemption as if no exemption was granted; and*
- vi. bagi pengecualian yang dimansuhkan dan tidak memenuhi syarat (iv) diatas, pelumba dikehendaki membayar balik duti/cukai mengikut kadar duti/cukai sewaktu kenderaan/motorsikal dilepaskan dari kilang atau semasa diimport manakala nilai kenderaan/motorsikal yang diambil kira untuk pengiraan cukai dibayar adalah nilai sewaktu berlakunya penjualan atau pertukaran milik kenderaan/motorsikal tersebut. *for withdrawn exemption or non compliance to conditions (iv) above, competitor is required to pay duties/taxes in accordance to the duties/taxes rate at the time of motor vehicle/motorcycle released from the factory or at the time of import whereas the value of motor vehicle/motorcycle taken for the calculation of payable taxes will be at the time of sale or ownership transfer of the said motor vehicle/motorcycle*

Conditions and Procedures for Applications

1. Companies/Individuals that are eligible to apply :

  - b. Application from motor sport competitor verified by MAM

  - c. For the sole purpose of motor sports.  
*Hendaklah digunakan untuk perlumbaan sukan bermotor sahaja.*
  - d. Cannot be sold or transfer ownership without written approval from MITI.  
*Tidak boleh dijual/dipindahmilik kepada pihak lain tanpa mendapat kebenaran bertulis MITI*
  - e. All importation process must be completed within the validity period of approvals.  
*Semua urusan pengimportan hendaklah diselesaikan dalam tempoh sahlaku AP; dan*
  - f. Importation accompanied with Certificate of Origin/Registration  
*Pengimportan disertakan dengan Certificate of Origin/Registration.*

- g. Applicants are required to observe the above stipulated conditions.
